## **Who we are?**

Nexis Advisory is the Investment Manager for the Walker Capital Fixed Income Fund (ARSN 653 791 916) and it is responsible for the distribution and marketing of the fund.

Nexis Advisory is a representative of, and acts on behalf of, Walker Capital, when it provides financial services to you.

## **Other Disclosure Documents we may give you**

You will not be provided with any personal financial product advice from Nexis Advisory. Any advice or information we provide to you is general advice only and does not take into account your personal objectives, financial situations or needs. It is up to you to decide whether or not you want to use our services, and if you need assistance or advice in this regard, you should consult a suitably qualified financial adviser. You will not receive a Statement of Advice from Nexis Advisory.

### *Product Disclosure Statement*

As the Investment Manager, Nexis Advisory may receive a portion of these fees as disclosed in the Walker Capital Fixed Income Fund PDS.
